

The Salvation Army Paul and Kay Rader Scholarship

Guidelines for the Central Territory

The Paul and Kay Rader Scholarship has been established in the Central Territory to encourage Salvationist minority students to attend accredited Christian Colleges and to use their knowledge as a Salvation Army Officer or Local Officer within their corps.

For the purposes of the Paul and Kay Rader scholarship, minority refers to any of the racial and ethnic populations within the United States identified as Hispanic / Latino, Black or African American, Asian, Native Hawaiian and Pacific Islander, American Indian and Alaska Native. Other students with immigrant status may also apply. If a student self identifies as multi-racial, at least 50 percent of heritage must be of a minority population.

Scholarships Awarded: Up to \$5,000 per year per accepted student based on demonstrated need

Maximum awarded Annually: Up to 5 Annual Scholarships not to exceed \$5000 for each scholarship

Eligibility:

- Applicant must be from the Central Territory
- Applicant must have a 2.0 or above grade point average on a 4.0 scale
- Applicant must be a senior soldier in good standing
- Applicant must attend an accredited four-year Christian college or university as a full-time student
- Applicant must be a minority (Non-Caucasian) student that wishes to become a Salvation Army Officer or serve through a local officer position in a corps.

Process and Guidelines

1. Scholarships are open to all undergraduate applicants with preference given to those in their Junior and Senior year of college
2. Applications must be made for a full year, no half semesters are accepted
3. The student must demonstrate financial need as indicated on the FAFSA report and the award letter from the college/university they are attending (a copy of FAFSA and the award letter must accompany the application for the scholarship)
4. The scholarship may be awarded annually, up to a maximum of four years, to the same individual if all eligibility requirements are met.
5. Children of Officers are not eligible for this scholarship

Instructions for Completing the Application Form

The attached application forms for the Paul and Kay Rader Scholarship are being sent to you to complete and return to your Corps Officer for his/her recommendation.

1. Complete the attached application form in full
2. Attach a copy of your registration or letter of acceptance for the Fall term
3. Attach a copy of your most recent transcript
4. Attach a copy of your completed FAFSA report
5. Attach a copy of your financial aid letter from the college/university you are/will be attending
6. Submit the original application, with all supporting documentation attached, to your Corps Officer for Corps Council consideration
7. Upon Corps Council approval the Corps Officer will forward the original application with supporting documentation to Divisional Headquarters for approval
8. Upon Approval, Divisional Headquarters will send the original application to the Territorial Officer Resource and Development Department for consideration
9. The deadline to submit the application is May 15th of the academic year applied for
10. Applications will be considered at THQ and the recipient will be notified by July 1st
11. Only complete and original applications will be considered

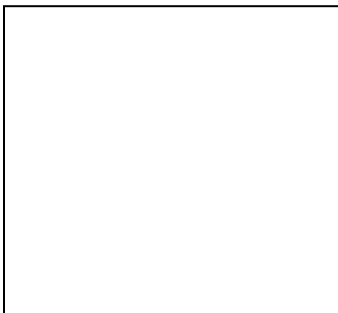
